# Strategic Purpose statement/ Te rautaki o te tohu

The purpose of this qualification is to provide the gasfitting sector with people who are skilled as gasfitting tradespersons and ready to apply for registration as a licensed gasfitter under the Plumbers, Gasfitters, and Drainlayers Act 2006.

This qualification is targeted at people working in the gasfitting industry and who can fulfil the requirements to obtain a limited trainee authorisation issued by the Plumbers, Gasfitters and Drainlayers Board.

Graduates will have the skills and knowledge required to be, once registered and licensed, authorised to legally carry out all gasfitting work. A licensed gasfitter can safely carry out gasfitting work with reduced risk of fire, explosion, and poisoning.

#### Graduate Profile/Ngā hua o te tohu

Graduates of this qualification will be able to:

- Apply practical knowledge of installation, commissioning and maintenance to complete work with consumer gas pipework.
- Apply practical knowledge of installation, commissioning and maintenance to complete work with gas appliances and equipment.
- Apply practical knowledge of installation, commissioning and maintenance to complete work with gas pressure and control devices.
- Apply practical knowledge of gas installations to determine ventilation and fluing requirements.
- Apply practical knowledge of installation, commissioning and maintenance to LPG installations for

- non-propulsive purposes in mobile applications.
- Apply practical knowledge of gasfitting drawings and specifications to interpret and produce drawings and records of as-built work.
- Apply the legislative responsibilities of a licensed gasfitter to gasfitting work.
- Apply practical knowledge of building penetrations to maintain the integrity of building structures and weather tightness.
- Work with consideration of other trades and related services on site and practice ethically.
- Apply material science and selection, trade physics, and trade calculations to complete work with gasfitting systems.
- Apply safe working practices and environmentally sustainable considerations to complete work with gasfitting systems.
