# 1. Purpose and audience (Te kaupapa me te hunga whakarongo)

#### 3. Background (Papamuri)

The 2025 Moderation Plan reflects that 2025 may be a year of 'transition' due to the changes that have been announced following the VET Consultation and the structure of Standard Setting Bodies in the future. The 2025 Moderation Plan, and the amount of post-assessment moderation called for, may change as 2025 progresses. Moderation activities for 2025 will be based on one or more of the following activities:

- 1. Assessment resources that were **pre-assessment** moderated during 2023 and 2024.
- 2. A provider's **internal** moderation plan: Aligning the sampling to the provider's internal moderation planning. This will be limited to ITP and WBL business units within Te Pūkenga for 2025.
- 3. Post-assessment moderation aligned to a current Assurance project or a particular industry focus.

#### 1. Pre-assessment Moderation:

The primary focus for 2025 is on the standards, and providers, that were pre-assessment moderated in 2023 and 2024, that have not been post-assessment moderated. This focus is based on two recommendations from NZQA in the 2024 monitoring report:

- Provide more in-depth reporting on how pre- and post-assessment moderation has influenced improvements for standards previously non-compliant
- Provide more analysis and reporting on education organisations that have been pre-assessment moderated. Report how many have met requirements in any subsequent post-assessment moderation, and what specific improvements were achieved

Results from this moderation activity will be feedback to NZQA through the 2025 self-assessment report.

The standards involved, from 2023-24 pre-assessment moderation, are specified in Section 4.

#### 2. A provider's internal moderation plan:

A provider may not be aligned to the pre-assessment standards identified above, but it is important that post-assessment moderation is called within each moderation cycle and that the quantity of the sampling is sufficient to be able to identify any theme.

Post-assessment moderation sampling under this activity shall be aligned to the provider's current internal moderation plan. Where an internal moderation plan is unavailable, the selection of standards shall be determined by the standard results reported through the annual NZQA Traffic or quarterly reports.

A maximum of five standards shall be called within any quarter of each assurance cycle unless there is a need to call for more samples.

Note: For 2025 this will be limited to the ITP and WBL business units within Te Pūkenga.

#### 3. Industry focus:

There are additional Assurance projects that Waihanga Ara Rau is undertaking based on 'themes' from across our assurance functions that include a focus on a particular industry sector. Additional post-assessment moderation samples maybe called from providers who have reported results from those specific industry sectors identified. This may also include site visits to observe delivery and assessment of particular standards.

Providers identified will be contacted directly prior to requests for post-assessment moderation samples being made.

For 2025 those industry sectors shall include:

- Plumbing, Gasfitting, and Drainlaying
- Scaffolding

#### 4. Standards to be post-assessment moderated (Ngā paerewa arotahinga matua, e aromātairua ā-muri)

The standards to be post-assessment moderated are outlined in the table below. This has been based on common assessment resources that were pre-assessment moderated in both 2023 and 2024.

**Note:** If the assessment resource for the standards listed is an [integrated assessment], then just submit the integrated assessment/s for post-assessment moderation.

# 5. High Risk and Capstone Standards (Ngā paerewa morearea me ngā paerewa Capstone)

At the time of development or review standards may be identified by the industry sector as high risk or a capstone standard. Industry expects that the assessment outcome for these standards be moderated on an annual basis to ensure that assessment is consistent and that any issues identified at the standard or assessment level are addressed at the time.
